

Notes on Contributors

Marinella Belluati is Researcher in the Faculty of Political Sciences at the University of Turin where she teaches 'Sociology of the Media' and 'Media Analysis'. She also contributes to the work of the *Osservatorio sulla Comunicazione Politica di Torino*, which has for a number of years had a focus on the study of political campaign communication. Her research interests include security and intercultural communication.

Brad Blitz received his Ph.D. from Stanford University and is Director of Graduate Research Programmes at Kingston University (London), where he is also Professor of Human and Political Geography. He has published extensively on issues of citizenship, migration and human rights. Recent publications include *Statelessness in the European Union: Displaced, Undocumented, Unwanted* (Cambridge University Press, 2011, with Caroline Sawyer), *Statelessness and Citizenship: A Comparative Study on the Benefits of Nationality* (Edward Elgar Publishing, 2011, with Maureen Lynch). He is currently completing a book on citizenship and mobility in Europe.

Mauro Degli Esposti was educated at the University of Bologna, where, in 1983, after several years of unpaid volunteer work, he obtained the post of 'free researcher'. He soon developed an international reputation as an independent multidisciplinary scientist, which was disregarded in three consecutive rounds of nationwide *concorsi* for posts of associate and full professor. Following the last of these he emigrated to Melbourne (Australia) where he took a fixed-term position as Senior Research Fellow at Monash University. Subsequently, after a brief but intense period of research as a visiting professor at LIAI (La Jolla, California), he moved to the UK where he rebuilt his academic career by becoming Lecturer in Molecular Toxicology in 2003. Since 2008 he has developed a network of Italian scientists, the Via-academy, the online activities of which have influenced the Italian media and politicians – but with little impact on higher-education policy, so far. He has published approximately 100 peer-reviewed papers and numerous articles in books, online magazines and newspapers.

Roberto Di Quirico is Lecturer in Political Science at the University of Cagliari. He received his Ph.D. from the European University Institute in

1998, and was Jean Monnet fellow at the Robert Schuman Centre for Advanced Studies and Post doctoral fellow at the *Istituto Italiano di Scienze Umane* in Florence. He has published on various topics related to international economic history and European politics. His latest book is *L'Euro, ma non L'Europa* (Il Mulino, 2008).

Phil Edwards lectures in Criminology at Manchester Metropolitan University. His research interests are in the area of political violence and contemporary Italian politics. He has published in *Modern Italy*, *South European Society and Politics*, as well as *Political Studies Review*. He is the author of *'More work! Less pay!' Rebellion and repression in Italy, 1972-77* (Manchester University Press, 2009).

Marco Geraci obtained a PhD in Applied Statistics from the University of Florence, in 2005. As post-doctoral fellow at the Department of Epidemiology and Biostatistics, University of South Carolina (USA), he developed statistical methods in various areas, including disease cluster detection, quantile regression for longitudinal studies, and geographical analysis with incomplete data. He subsequently carried out research in the epidemiology of and statistical methods for cancer in young people with the Cancer Research UK Paediatric and Familial Cancer Research Group at the University of Manchester, and collaborated with scientists of international standing in the medical field. In 2010 he was appointed Lecturer in Biostatistics at the Institute of Child Health, University College London. He has published in leading statistical and medical journals, and contributed to a number of international conferences.

Chris Hanretty earned his PhD degree at the Department of Political and Social Sciences of the European University Institute. His PhD thesis addressed the politics of public media broadcasting in six European countries. He is currently Lecturer in Politics at the University of East Anglia. His other main research interests are Italian politics and electoral studies.

Costanza Hermanin is a PhD researcher in the Department of Political and Social Sciences of the European University Institute and a Fulbright fellow at Columbia University. Her PhD thesis looks at the implementation of EU policy against racial and ethnic discrimination in three European countries. Her other research interests concern EU institutions and policy-making, and citizenship and immigration policy at EU level and in the member states.

Alison Jamieson was born and educated in Scotland. Since 1984 she has lived in Italy, working as consultant and author on issues of political violence, organized crime and drugs. She lectured at the Nato Defense

College, Rome between 1992 and 1997, and has worked as consultant to the United Nations Office on Drugs and Crime and was Project Manager and principal author of the UN's first *World Drug Report* (Oxford University Press, 1997). She is on the editorial board of the journal *Studies in Conflict and Terrorism* (Taylor & Francis). Her publications include *The Heart Attacked: Terrorism and Conflict in the Italian State* (Marion Boyars, 1989) and *The Antimafia: Italy's Fight against Organized Crime* (Palgrave, 1999). At the moment she is completing a book version of the conversations with Cossiga.

Francesco Marangoni is currently a post-doctoral fellow in the faculty of Political Science of the University of Bologna at Forlì. He is affiliated with the Centre for the Analysis of Public Policy (CAPP), a research unit of the Department of Political Science at the University of Bologna. Daniela Piana is Associate Professor of Political Science at the University of Bologna, where she teaches "Politics and Institutions of the EU". She is author of *Judicial Accountabilities in New Europe* (Ashgate, 2010) and scientific coordinator of the first European academic network on judicial studies.
